Users can sign up for e-mail notifications when new content is posted to the portal.

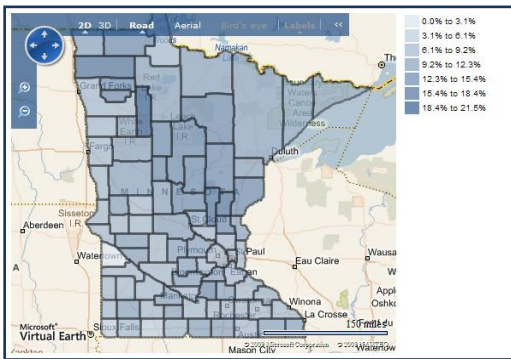
## Store data and metrics
