Add the following condition to Contract 64016:

86. PRICE ADJUSTMENT Price adjustments shall be equal to the annual percentage change (increase or decrease) of the U. S. Department of Labor Bureau of Labor Statistics Employment Cost Index ("ECI"), computed using data on Table 8—"for wages and salaries, for civilian workers" for "Service Producing Industries" for the month of the contract's anniversary date.

Price adjustments for succeeding years of the contract will be administered and new pricing effective on each successive anniversary date of the contract. No price increase shall exceed 5% annually.

Requests for price increases must be made in writing at least 30 days prior to the anniversary date of the contract. Requests made after that time will not be considered.

It shall be Contractor's responsibility to request and to provide documentation satisfactory to the Purchaser to support any increases. Documentation shall include, but is not limited to, all applicable product indices and other direct costs to substantiate Contractor's request for price increases.

Price increase requests will not be granted retroactively for past years or years in which the Contractor failed to request price increase(s). It is the policy of the City not to allow for any price adjustments ("surcharges") for fuel or energy cost increases.




