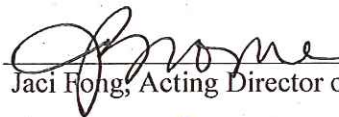

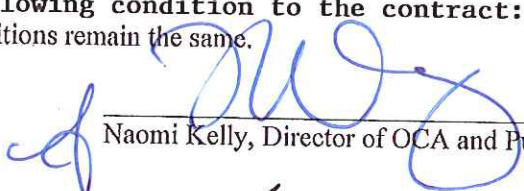

Electronic payment. The City and County of San Francisco (City) uses Bank of America's PayMode-X system to pay invoices **electronically** and **not by check** whenever possible. The City makes PayMode-X payments every business day, **but starting July 2010 will process, print and mail paper checks only one day a week.** So the City encourages you – and it is greatly to your benefit – to enroll in PayMode-X now.

There is no cost to you to enroll in PayMode-X, and you get the same information electronically from PayMode-X that you would get on the City's check stub.

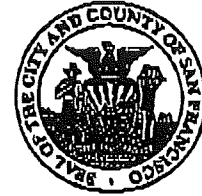
35. Food Service Waste Reduction Requirements. Effective June 1, 2007, Contractor agrees to comply fully with and be bound by all of the provisions of the Food Service Waste Reduction Ordinance, as set forth in San Francisco Environment Code Chapter 16, including the remedies provided, and implementing guidelines and rules. The provisions of Chapter 16 are incorporated herein by reference and made a part of this Agreement as though fully set forth. This provision is a material term of this Agreement. By entering into this Agreement, Contractor agrees that if it breaches this provision, City will suffer actual damages that will be impractical or extremely difficult to determine; further, Contractor agrees that the sum of one hundred dollars (\$100) liquidated damages for the first breach, two hundred dollars (\$200) liquidated damages for the second breach in the same year, and five hundred dollars (\$500) liquidated damages for subsequent breaches in the same year is reasonable estimate of the damage that City will incur based on the violation, established in light of the circumstances existing at the time this Agreement was made. Such amount shall not be considered a penalty, but rather agreed monetary damages sustained by City because of Contractor's failure to comply with this provision.

36. Lead-Time. If the City places an order for products during the contract extension and the products are not available at the time of order ("Backorder"), the delivery lead-time for said Backorder shall be ninety (90) calendar days after receipt of order. DGM

MÖDEL: Flying Cross by Fochhelmer #SFMSKIRT01.

FABRIC: Content: 55% Polyester, 45% Wool; Weight: 16-1/2 - 17 oz. per linear yard; Weave: : Elastique; Color: Chocolate Brown; Fabric Reference: Raeford 645-983 with Restora

STYLE: The skirt shall be hemmed, knee length, with triple pleated front styling, 2 side seam pockets, four belt loops, and center back zipper, and slight flair (A-Lined).

WAISTBAND: Waistband shall be 1-1/2" wide, folded, with 1-1/4" long extension on underside to button in center back.

BELT LOOPS: There shall be four belt loops measuring 3/8" wide by 1-3/4" long. Loop to be positioned over each dart and one over center pleat on left front.

ZIPPER: YKK 7" long over lapping side to be set back 3/8" to hide zipper track.

FRONT PANEL: There shall be three 1-1/2" pleats located on the left front. Pleats are sewn closed both vertically and horizontally at a point approximately 11" from the bottom of a finished hemmed.

BACK PANEL: Two piece back with appropriate darts located approximately 3-1/2" from zipper on size 12. Located on the waistband is a 22 light bone four holed bone button secure closure.

SIDE POCKETS: To be made of outershell fabric and to be horizontal bartacked at the pocket.
